### Federal Policy Updates & National News:

- Since the release of the President's Budget which threatened afterschool and summer programs afterschool advocates across the country united to send a strong message to Congress: Keep funding for the local programs that keep kids safe, inspire them to learn, and help working families. In just a short time:
  - Over 11,000 people have contacted their representatives in Congress, resulting in more than 33,000 emails and calls.

- On May 5, a letter coordinated by the Afterschool Alliance was sent to Congressional Appropriators in support of 21st CCLC funding, signed by 260 local, state, and national organizations, representing all 50 states.
- On May 6, 55 advocates from 19 states went to Capitol Hill and met in person with nearly 70 offices as part of the Afterschool for All Challenge.

- Congressional Activity
  - **2026 Budget:** the administration's budget appears to cut approximately 33% of federal education funding and appears to eliminate the 21st Century Learning Center grants. **TRIO, GEAR UP, Federal Work Study, Preschool Development Grant Birth through Five (PDG B-5)** programs are also proposed for elimination.
  - **Reconciliation Process:** on-going negotiations continue among Republicans. Cuts will likely include SNAP, Medicaid.
  - **AFTERSCHOOL ACT** reintroduced. It would establish a \$15 million non-competitive grant to support youth development programs in high juvenile offense rates.
  - The bipartisan **Early Childhood Nutrition Improvement Act of 2025**, makes several improvements to streamline the CACFP and ensure children are fed healthy meals throughout the day.
- Administrative Updates
  - **ESSER Extension** - A judge ruled last week to reinstate ESSER extension funding to 16 states and DC. [Read the blog.](#)
